

## Chapter 72

### GOVERNMENT AND ELECTIONS

**[HISTORY: Adopted by the Town Board of the Town of Scott as indicated in article histories. Amendments noted where applicable.]**

#### ARTICLE I

##### Supervisors

**[Adopted 11-14-1977 by Ord. No. 3-1977]**

#### **§ 72-1. Purpose.** <sup>1</sup>

The purpose of this article is to increase the number of Supervisors of the Town Board of the Town of Scott from its present size of three Supervisors to five Supervisors under authority of the provisions of § 60.21, Wis. Stats., and to provide for the division of the Town of Scott into three separate and distinct wards which shall elect Supervisors and the Town Chairman on an at-large basis.

#### **§ 72-2. Number of Supervisors increased.**

The Town Board of the Town of Scott, Sheboygan County, Wisconsin, shall be increased from its present size of three Supervisors to five Supervisors under authority of the provisions of § 60.21, Wis. Stats.

#### **§ 72-3. Wards; polling place.** [Amended 7-11-1991 by Ord. No. 3-1991<sup>2</sup>]

A. Wards. The Town of Scott shall be divided into three wards.

- (1) The First Ward will consist of that portion of the Town of Scott beginning in the Sections 17 and 18 south of Tower Road and County Hwy A South, east to the Town line Sections 24, 25 and 36.
- (2) The Second Ward will consist of the part of Sections 1, 10 and 16 south and east of County Hwy S and north of County A, south to County Hwy W.
- (3) The Third Ward will consist of the Sections 3, 4, 5 and 6 south of County W east of Forest View Drive, north of Tower Drive, south of County Hwy A to County Hwy S and all sections north and west of County Hwy S to County Hwy W.

B. Polling place. The polling place servicing the First, Second and Third Wards shall be the Town Hall located on the northwest corner of Boltonville Road and CTH A.

#### **§ 72-4. Terms of office; election.**

- A. The two Supervisors elected at the 1978 spring election shall serve a two-year term and shall be subject to reelection at the spring election in every even-numbered year thereafter.
- B. Commencing with the 1979 spring election:
  - (1) The two existing Supervisor positions shall be filled from Wards 1-3. The candidates for Supervisor positions must be duly qualified electors for the position available.<sup>3</sup>
  - (2) The two newly created Supervisor positions shall be filled from Wards 1-3. The candidates for Supervisor positions must be duly qualified electors for the position available.<sup>4</sup>
  - (3) The Supervisor who is Town Chairman shall be elected on an at-large basis. The Chairman shall serve a two-year term and be subject to reelection in every odd-numbered year thereafter.
- C. The two Supervisors elected at the 1979 spring election shall serve a two-year term and be subject to reelection in every odd-numbered year thereafter.

**§ 72-5. Quorum.**

Any three Supervisors shall constitute a quorum of the five-Supervisor Town Board.

ARTICLE II

**Wards**

**[Adopted 7-11-2011 by Res. No. 2011-1]**

**§ 72-6. Wards established.**

- A. By adoption of this resolution, the Town of Scott will be divided into three wards as depicted on the attached map which is incorporated herein by reference and is adopted by the Board of the Town of Scott on a vote of five ayes and zero nays. Ward 1 will consist of sections south of Tower Road and County Hwy A South, east to the Town line. Ward 2 will consist of the sections south and east of County Hwy S and north of County A south to County Hwy W. Ward 3 will consist of the sections south of County Hwy W east of Forest View Drive, north of Tower Drive, south on County Hwy A to County Hwy S and all sections north and west of County Hwy S to County Hwy W.
- B. The Town Clerk shall within 10 days transmit a copy of this resolution to the County Clerk for Sheboygan County.
